

# Trisam – early rehabilitation through collaboration Collaboration and information exchange

Trisam is a collaboration between Region Gävleborg (primary care and psychiatry), Försäkringskassan (the Swedish Social Insurance Agency), Arbetsförmedlingen (the Swedish Public Employment Service) and the municipality. There are Trisam collaboration teams in every municipality in the county of Gävleborg. The Trisam-teams consist of healthcare professionals and caseworkers from Arbetsförmedlingen, Försäkringskassan and the municipality. Region Gävleborg contributes rehabilitation coordinators and where required healthcare professionals. Our purpose is to provide you with better, more integrated support in your rehabilitation process.

**In order to be able to share information we need your consent** – *if you are currently in contact with Försäkringskassan regarding an ongoing matter, a caseworker from Försäkringskassan will get in touch in order to collect your consent. This is so that Försäkringskassan can share information about you with its partners in this collaboration* 

In order to be able to help you in the best way, we all need to have the same information about you and your circumstances. For this reason we need written consent from you allowing us to share the necessary information with each other. This information is protected by confidentiality.

### **Information needed includes:**

- state of health
- details of employment
- previous rehabilitation care
- social and financial circumstances
- previous investigations
- expert opinions, such as medical reports

The consent form is on the following page. The consent applies from the day you sign the form throughout the period of coordination of your rehabilitation. It will apply no more than one year from when you sign your consent.

You can withdraw your consent at any time You can do this by contacting your caseworker at the relevant authority or your contact person at your health centre/clinic.
